

OFFICIAL RULES AND REGULATIONS

“Sudbury Wolves Tickets Giveaway” Rules and Regulations

Description: The “Sudbury Wolves Tickets Giveaway” (the “Giveaway”) is brought to you by Vianet Inc. By entering the Giveaway, each entrant agrees to abide by and accept these Official Giveaway Rules and Regulations (the “Rules”).

The Rules are subject to change without notice. Changes to the Rules will be posted at www.vianet.ca/promos. Participants are responsible for checking the website and agree to abide by the most recent rules posted as of the end date of the Giveaway. No purchase necessary.

Giveaway Periods: Giveaways are planned through the 2016/2017 Sudbury Wolves season. Each Giveaway commences 9:00am Eastern Standard Time (“EST”) on the first Monday, and ends 9:00am EST on the second Monday of each promotional period. (the “Giveaway Period”).

Giveaway Period #3 : Monday, November 21, 2016 - Monday, November 28, 2016 (for Dec 2nd, North Bay @ Sudbury)

Giveaway Period #4 : Monday, November 21, 2016 - Monday, November 28, 2016 (for Dec 3rd, Barrie @ Sudbury)

Eligibility: The Giveaway is open to all legal residents of Canada, excluding residents of Québec, who have reached the age of majority in their province of residence as of the first day of the Giveaway Period. Notwithstanding the above, the Giveaway is not open to individuals associated with the Giveaway, including the employees, agents or representatives of Vianet Inc. and suppliers providing prizes or other materials or services in connection with this Giveaway (collectively referred to as the “Excluded Individuals”). This Giveaway is also not open to the immediate family members, specifically spouse, children and parents of, or those who reside with, the Excluded Individuals.

Entry: No purchase necessary to enter or win. There are two ways to enter the giveaway.

attention "Sudbury Wolves Tickets Giveaway". Upon receiving completed entry, he or she will receive one ballot into a draw for the Giveaway. All entries must be received during the Giveaway Period.

Prizes: There is one prize per giveaway available to be won. Each prize is a pair of Sudbury Wolves tickets with a total estimated value of forty-five (\$45) CDN.

Terms and Conditions: The prize has no cash value and cannot be redeemed for cash. In addition, the prize is non-transferable. This giveaway is in no way sponsored, endorsed or administered by, or associated with Facebook. You understand that you are providing your information Vianet and not to Facebook.

Draw: An employee of Vianet will use a randomization application to draw for each of the prizes. The draw will take place in Sudbury, Ontario during the afternoon of the second Monday of each Giveaway Period. The potential winner will be announced on the Vianet Facebook page by a representative of Vianet, and must respond within 72 hours to maintain eligibility. In the event a winning entry was made by mail, the individual will be contacted by phone by a Vianet representative, and must be reached within 72 hours to maintain eligibility. In order to be declared a winner by Vianet, a potential winner must be in compliance with these Rules, and must correctly answer (without assistance of any kind) a time limited skill-testing question. In the event that a potential prize winner does not comply with these Rules and/or does not correctly answer the skill testing question or is not reachable within the notification period referred to above, Vianet reserves the right to disqualify such entrant from the Giveaway and select further entrants from the remaining eligible entries until a winner is finally declared.

Odds of Winning: The odds of winning any drawing will be determined by the number of eligible entries received.

Release: Prior to receiving a Prize, the winner will be required to sign an affidavit of eligibility and release form releasing Vianet from all liability relating to the Giveaway and the acceptance of any Prize, confirming compliance with the Rules and consenting to the use of his or her name and photograph, without further compensation, in any publicity carried out by Vianet and/or their advertising and promotional agencies.

Privacy: Personal information collected from entrants will be used by Vianet for the purpose of administering this Giveaway and each entrant consents to the collection, use and disclosure of personal information in accordance with Vianet's privacy policy located at www.vianet.ca.

Banning: Any attempt to tamper with the entry process, interfere with these Rules, deliberately damage any website or undermine the administration, security or legitimate operation of the Giveaway, is a violation of criminal and civil laws and Vianet reserves the right to seek damages and/or other relief from all persons responsible for such acts to the fullest extent permitted by law and ban or disqualify such persons from this Giveaway and future giveaways.

Prize winner is solely responsible for arranging for the pickup and claim of all Prizes from the participating Vianet Office and are solely responsible for any and all costs associated with delivery.

In addition, VIANET will provide the associated Prize providers with the winner's contact information when applicable, as completed on their entry, so that Vianet may contact the winner directly to complete the details of the prize redemption.
